Training Course Content (1 day)

Introduction

The panel leader is a key element for the success of a sensory project. Indeed, the panel leader is responsible for the selection, training, and management of the sensory panel, and for the evaluation and reporting of the data generated.

Becoming an effective panel manager and getting the best out of the panellists require a set of skills and personality traits ranging from leadership to ability to communicate with panellists and analytical thinking. Panel leaders must also ensure that good health, safety, ethical and legal practices are adopted when conducting sensory panels.

The aim of this course is to provide sensory professionals with an insight of the role of the panel leader, the key personal traits and skills to perform the role as well as important health, safety, ethical and legal considerations when conducting sensory panels.

1 - Health, safety, ethical and legal considerations when conducting sensory testing

- Importance of ensuring health, safety, ethical and legal treatment of assessors
- Legislation and professional codes of conduct
- Independent ethical committee review
- Important considerations when recruiting and selecting assessors: informed consent, best practices, health monitoring and compensation.
- Safety of test samples: microbiology, toxicology, allergens
- Safety of assessment procedure: amount of product consumed and method of assessment
